INSTRUCTIONS to "Student Advocates"

The following Timetable details the format for this workshop. Tasks have been set in each performance session of the timetable for you to individually **present that set task** before a Judge/Instructor in the same manner that you would present in court. The tasks include both performance and acting as a witness. Where you been asked to play the role of witnesses, please be completely familiar with the witness statements and have a thorough knowledge and understanding of the facts of the case study.

If you are not totally familiar with the requirements of any particular task, you may find it helpful to refer to the "Specific Advocacy Tasks" summary at the end of the Course Materials document. Please prepare to present the whole of the task, even though you will be given a time limit of 5 minutes to present during the workshop. You will be reviewed on the part you present.

We acknowledge that the case studies used here may not be the type of cases you generally deal with or not from your regular jurisdiction. We use them because they are very good case studies for advocacy teaching, demonstrating skills that can be applied in any jurisdiction.

Note that NO preparation time is included during the actual workshop. Please prepare each of your set tasks between now and when the workshop commences. Please **allow yourself time to prepare properly**. Don't get bogged down in your preparation with any legal technicalities within the case studies. Do not be distracted with "the law". Don't bring statutes or precedents. Evidence is restricted to only that contained within the case studies.

Once you have given your performance, you will then be given feedback by a Trainee Instructor as part of their training. This review is designed to give you advice and skills in improving your advocacy and is not intended to be 'destructive' ... it is a helpful and positive direction for you to learn.
